## RE: <u>Support for Capital Budget Request to Acquire Wayne Public Golf Course</u> as a Benefit to Chinook Salmon Recovery

Dear Representatives Dunshee, Stanford, DeBoldt, and Smith:

On behalf of the Lake Washington/Cedar/Sammamish Watershed (WRIA 8) Salmon Recovery Council, I wish to convey the potential significance and value of acquiring the Wayne Public Golf Course along the Sammamish River in the City of Bothell to local and regional salmon recovery. The WRIA 8 Salmon Recovery Council is a partnership of 28 local governments, citizens, community groups, state and federal agencies, and businesses working together to implement the *WRIA 8 Chinook Salmon Conservation Plan* (WRIA 8 Plan). The City of Bothell one of our local government partners—submitted a capital budget request targeting protection of the Wayne Golf Course. Fulfilling this request would enable regionally-significant habitat restoration benefitting threatened Chinook salmon and other fish and wildlife.

The Wayne Golf Course, located at 96th Avenue NE in the City of Bothell, extends along the left and right banks of the Sammamish River and has over 4,500 linear feet of river frontage. The WRIA 8 Plan identifies the Sammamish River as a

> migratory corridor critical to restoring Chinook to the North Lake Washington basin. In addition to Chinook, the river is also used by coho, sockeye, and kokanee salmon.

Salmon habitat along the Sammamish River is highly degraded, and water temperatures can reach levels lethal to salmon. Acquisition of the Wayne Golf Course is a rare opportunity to protect substantial acreage in a primarily urban area, and protection would provide a significant opportunity to implement the restoration priorities identified in the WRIA 8 Plan on a large scale.

Local salmon recovery funding alone is not sufficient to acquire properties of this size, and we ask you to support this important capital budget request. Acquiring the Wayne Golf Course for the purposes of habitat protection and restoration would contribute significantly to WRIA 8 and Puget Sound salmon and ecosystem recovery objectives.
